Abstract // Resumo:

As a result of an ageing global population, 21 out of 27 European countries are forecasting an increase in the retirement age by 2030. Assuming that people will have to work longer, it is imperative to understand under which work and health conditions they feel capable of doing so. Using a cross-national public database, a sample of participants aged 68+ from 24 European countries (N=3,156) was considered, and the group of participants who were still working was compared to the group who were already retired. Through a binary logistic regression, it was possible to understand that disagreement with recognition at work is a significant predictor of retirement. Even for older workers who are stable in terms of employment and health, continuing to work beyond retirement age may not be an option, as they do not experience recognition for their contribution from leadership, peers, or the culture of the organization where they work. This data reinforces the importance of organizations keeping in mind the importance of developing practices to achieve a less stereotyped view of age on the part of leaders. It is concluded that the extension of the retirement age can not neglect the work conditions and must be accompanied by measures that promote recognition of the work of all workers.

Proteção social de média complexidade à saúde integral para idosos: centro-dia

Abstract // Resumo:

Introdução: Espaços que prestam assistência diurna para as pessoas idosas e seus familiares, conhecidos como Centros Dia para Idosos (CDI), estão aumentando em número nos municípios brasileiros e têm relevância social. Objetivo: Caracterizar o perfil de idosos que procuram vagas para cuidados diurnos em dois municípios do oeste do estado de São Paulo, Brasil. Metodologia: Natureza exploratória, descritiva e de abordagem qualitativa e quantitativa. A análise foi baseada nos fundamentos de conteúdo, cuja coleta foi efetuada no banco de dados de um grupo de pesquisa, referente aos dados de 26 instituições de acolhimento integral e verificou-se a busca por vagas para cuidados diurnos, do tipo CDI para 25 idosos, no ano de 2020. Todos os cuidados éticos foram observados. Resultados: Das 25 solicitações por vagas de cuidados diur-
