



# Agreement for Mutual Academic Recognition

# Master degree in Management at FEP - Universidade do Porto and "Master in Administration" at FEA – Universidade de São Paulo

## Call and Application Procedures International student in mobility in FEA-USP (2<sup>nd</sup> semester 2020/21 and 1<sup>st</sup> semester 2021/22)

# 1) What will change in the Master in Management (MIM) programme at FEP if a student wishes to take Academic Recognition from FEA-USP?

The student will have to

- undertake the courses from the 1<sup>st</sup> to the 3<sup>rd</sup> semesters of the programme as defined in the Study Plan in Annex;
- be approved in the public defense of the Dissertation. Dissertation has to fulfill the following requirements:
  - 2 co-supervisors must be addressed (one from FEP and other from FEA-USP)
  - Dissertation work should be equally split between the period of stay in both institutions during the 2<sup>nd</sup> year of the program
  - Dissertation must be written in English and must contain a summary page with Title, Abstract and Keywords, in English and Portuguese
  - Public defense examination must be in English and takes place at the Home institution.

#### 2) How many students will be selected?

Up to 2 students.

#### 3) Are students entitled to a scholarship?

Although not guaranteed, students are eligible for a scholarship (*e.g.*, Santander). However, students can apply only during the  $2^{nd}$  semester (while already studying at FEA-USP) to a scholarship for the  $3^{rd}$  semester. Information will be given by FEP when the call is open.

#### 4) What are the tuition fees?

FEP students are exempted from paying tuition fees at FEA-USP and will only have to pay tuition fees at FEP.





#### 5) Application and Selection procedures

**STEP 1**: Students wishing to apply to the Mutual Academic Recognition programme (FEP/FEA-USP) must upload a motivation letter at <u>Acordos de Reconhecimento Académico Mútuo FEP-FEA/USP</u> before **September 22, 2020**.

Eligibility criteria:

- FEP Master in Management students.
- Students must successfully complete a total of 30 ECTS (1<sup>st</sup> semester) and hold one of the following certificates confirming proficiency in English: IELTS min 6.0, TOEFL IBT min 79, or equivalent.

#### Admission and Selection criteria:

Students will be selected based on their rank position in the admission to the Master in Management at FEP, provided they meet the above eligibility criteria. Student selection must be accepted by both institutions.

STEP 2: Students will be informed until September 25, 2020, about the selection results by email.

**STEP 3**: Applicants should confirm their application before **September 28, 2020**, about the selection results by email to <u>jantonio@fep.up.pt</u>.

**STEP 4**: FEA-USP will send information about the application procedures to FEP.

**STEP 5**: In **September**, selected applicants should submit the following study plan for one semester for approval by MIM director, in accordance with the requirements for the 2<sup>nd</sup> semester at FEA-USP.

(\*) Conditional course taken in FEA-USP is to substitute for Data Analysis, either 'Análise Estatística e Amostragem' or 'Análise Preditiva de Dados'. The conditional course can be taken either in the 2<sup>nd</sup> or the 3<sup>rd</sup> semester while in FEA-USP.

**STEP 6**: Selected applicants should submit their application **before the 15<sup>th</sup> of October 2020** to FEA-USP. For queries about the application process the contact is Márcio Fernandez Cuzziol (<u>ccintfea@usp.br</u>).

**STEP 7**: In **December**, students should also apply for a mobility period in the regular call for the 3<sup>rd</sup> semester with the following plan. The choice of elective courses to be attended at FEA-USP should be previously set in agreement with the director of the MIM.

**STEP 8**: Students should apply as an outgoing mobility student of FEP/University of Porto for the 2<sup>nd</sup> semester, before the deadline established for the 2<sup>nd</sup> call E+ (**September 2020**). For the 3<sup>rd</sup> semester a similar application is due, before the deadline established for the 1<sup>st</sup> call E+ (**January 2021**). FEP International Mobility Unit will contact, timely, the selected students regarding these procedures.

**STEP 9**: In both application moments as an outgoing mobility student of FEP/University of Porto, students must:


- a. Fill in, sign and deliver, in hand, the application form (for E+ mobility purposes) to the International Mobility Unit. Application form is available in SIGARRA, "Mobilidades" (Mobilities). The choice of elective courses to be attended at FEA-USP should be previously set in agreement with the director of the MIM.
- b. Upload the following documents in their application (SIGARRA):
  - Copy of the Passport;
  - Copy of private health insurance contract;
  - PT/BR 13 Certificate of entitlement to health care in Brazil;
  - Curriculum Vitae (English);
  - Bank details (IBAN, student's name).
- c. Pay online, or at FEP Treasury services, a 50€ guarantee fee, after being selected; this fee will be returned to the student at the end of the mobility period.
