# Specific conditions to access the cycle of studies

In order to apply for the doctoral program in Telecommunications, candidates must meet the following conditions:

- a) to have a master's degree or a 2nd cycle of higher education in Electrical Engineering, Telecommunications, Electronics or related fields;
- b) to have a degree in higher education, obtained in a national or foreign institution, recognized as valid by the Scientific Committee of the Programme;
- c) to have a professional or scientific curriculum recognized as relevant and appropriate by the Scientific Committee.

# Criteria and sub-criteria for selection and ranking of applicants Applications are scored from 1 (minimum) to 5 (maximum) in the three evaluation criteria considered. Candidates are ranked according to the weighted average rating of the three criteria. The weighting factors are respectively 6, 2 and 3. • Merit of the candidate as assessed by the curriculum vitae; 6/11\*100 • Merit of the candidate as recognized by reference letters (a penalty applies if less than 3 letters are presented); 2/11\*100 • Merit of the candidate as inferred from the declared objectives and motivation to attend the Doctoral Programme. 3/11\*100

# Applicants tie-breaking criterion

The tie-breaking criterion is the assessment of the curriculum vitae.
