## Specific conditions to access the Cycle of Studies

Applicants who may apply to this Cycle of Studies:

- Holders of a Bachelor's Degree or legal equivalent in the field of Engineering, Physical, Life, Formal, and Applied Sciences, as well as Social Sciences of a more quantitative nature, such as Accounting, Economics and similar areas. All these areas will, from now on, be referred to as suitable areas.
- Holders of a foreign higher academic degree conferred following a first cycle of studies organized according to the principles of the Bologna Process by a country adhering to this Process;
- Holders of a foreign higher academic degree in an appropriate area that is recognized as meeting the objectives of the Bachelor's Degree by the statutorily competent scientific body.
- Holders of an academic, scientific or professional curriculum that is recognized as attesting the ability to carry out this Cycle of Studies by the statutorily competent scientific body:
- a) "Final-year students" who have reasonable expectations of obtaining their Bachelor's Degree by the end of the enrolment deadline of their application phase, regardless of their IES of origin. These applicants lose their right to their place within the competition in question, if they are not able to register within the deadline:
- b) Applicants who, not being covered by the previous point, explicitly wish to request FEUP's statutorily competent scientific body to certify their capacity to carry out the Cycle of Studies to which they apply.
- Proven proficiency in English is required.

Criteria and subcriteria for selection and ranking of applicants	
1. The Average for Application (MC), expressed on a scale of 100 to 200 values rounded to the nearest unit, represents the applicant's final grade average of the Degree (180 ECTS) or the current average in the Degree (at the date of application) in the case of final-year applicants; In the case of applicants who have already completed other Bachelor's and/or Master's Degrees in suitable areas, the Average for Application is the simple average of the final grades of these degrees.  Note: In situations which the documentation provided by the applicants does not mention the final average of the grades set in 1, and it is not possible to calculate it, the missing final averages will be considered with a value of 100 (in the range 0-200) in the calculation of the Application Average.	38,50%
2. The Suitability of the Academic Curriculum (ACA) represents the assessment of the Board of this Cycle of Studies regarding the "level of coverage of key scientific areas" that the study plan of the Degrees of origin and the curriculum vitae provide. The assessment of this component (expressed on a scale of 100 to 200 points, rounded to the nearest unit) should essentially focus on the suitability of training and professional experience to enter the cycle of studies.	17,50%
