2nd Cycle of Studies in Public Health

## A – Specific conditions for accessing the study cycle

According to the general regulations for the 2nd and 3rd study cycles of UPorto, the SC Scientific Committee is responsible for this information and it is subject to approval by the Faculty Director. However, this does not apply to study cycles merged with other University Institutions, to which the principles defined in the respective collaboration agreement apply, as well as in the specific regulations of the study cycle, formulated according to the Legal Regime of Degrees and Diplomas of Higher Education (DL 65/2018, of 16th August).

Whenever possible, the scientific areas of the qualifications required for the application should be mentioned.

pecific conditions for accessing the study cycle
Candidates may apply to the cycle of studies leading to the degree of Master of Public Health if they hold:  a Bachelor's Degree or Integrated Master's Degree in the area of Health Sciences or related areas.  b) Degrees from foreign universities in the area of Health Sciences or related areas, through curricular evaluation by the Scientific Committee;  School, scientific or professional curricula that are recognized as attesting the capacity to carry out this cycle of studies by the statutorily competent scientific board of the university institution.

## B – Criteria and sub criteria for selection and serialization of candidates

Selection and serialization criteria should be defined using clear, objective and easily applicable and justifiable parameters in order to safeguard the transparency and rigor of the applications' evaluation.

The assessment of criteria and sub-criteria measured by a numerical scale allows a more objective evaluation of the potential and academic/scientific/artistic/professional skills and capacity of the candidates.

Criteria and sub criteria for selection and serialization of candidates	
1-The candidates are selected by the Scientific Committee of the Study Cycle, taking into consideration the candidate's Academic, Scientific and Professional Curriculum.	
2- Candidates will be ranked based on:	
a) grade of bachelor or integrated master (CL): 10 points =1; 11 points =2; 12-13 points =3; 14= 4; 15 to 20 points = 5	multiply the grade by 2.5

b) Scientific Curriculum:	
Publications (P): no publications=0; only publications in Portuguese journals = 1; publications in indexed international journals =2	
The weighting factor for this item will be 0.75 (consider the product of the grade by 0.75).	
Communications (C): No communications =0; Communications in national or international congresses as co-author (other than 1st) =1; Communications in national congresses as 1st author =2; Communications in international congresses as 1st author =3	
The weighting factor for this item will be 0.5 (consider the product of the grade by 0.5).	
c) Professional curriculum (CP): No professional experience =0; Research fellow =1; Professional experience in other than health area =2; Professional experience in health area =3	multiply the grade by 1
d) Frequency of the Specialization Course in Public Health of the Internato Médico em Saúde Pública (CESP): no=0; yes=1	multiply the grade by 1,5
3. The final classification (CF) to be attributed to each candidate, to be used in the seriation, will be obtained by weighting expressed in the following formula: CF=2,5CL+(0,75P+0,5C)+CP+1,5CESP	
Note: A minimum final classification (CF) of 9.5 points should be considered the minimum requirement for admission to the master's program.	
Tie-breaking criterion for candidates (may be the classification in some of the elements of the previous table)
