3rd Cycle of Studies in Biomedicine

**A - Specific conditions for access to the cycle of studies**

*According to the general regulations of the 2nd and 3rd cycles at U.Porto, this information is the responsibility of the EC Scientific Committee and is subject to approval by the Faculty Director. Exception made to **cycles of studies in conjunction with other HEIs**, to which the principles defined in the respective collaboration agreement apply, as well as in the specific regulation of the cycle of studies, formulated according to the Legal Regime of Degrees and Diplomas of Higher Education (Portuguese Decree-Law no. 65/2018, of August 16th). Whenever possible, the scientific areas of the qualifications required for the application should be mentioned.*

**Specific conditions for access to the cycle of studies**

- a) Undergraduates or holders of a Master's degree in Medicine and other areas related to Biological and Health Sciences, obtained in Portuguese or foreign universities may apply for the 3rd Cycle of Studies in Biomedicine;
- b) After consulting with the Scientific Committee, undergraduates or masters degrees from other areas may also be accepted;
- c) Holders of an academic or professional curriculum recognized as attesting to the capacity to carry out this cycle of studies by the Scientific Committee may be admitted to the 3rd Cycle of Studies in Biomedicine.

**B - Criteria and sub-criteria for selection and seriation of candidates**

*The selection and seriation criteria should be defined using clear, objective, easily applicable, and justifiable variables, to safeguard the transparency and rigor of the evaluation of the applications. The assessment of criteria and sub-criteria measured using a numerical scale allows a more objective evaluation of the candidates' academic/scientific/artistic/professional potential and capability.*

**Criteria and subcriteria for selection and seriation of candidates**

A. Candidates for enrollment will be recommended by the Scientific Committee, considering the candidate's background and curriculum vitae. Applications will be ranked based on final grade classification, attainment of the master's degree, and relevance of the scientific curriculum and professional experience:	50%
A1. Undergraduate classification - 25% (<14 points - 0; 14 to 15 points - 1; 16 to 17 points - 2; and >=18 points - 3);	25%
A2. Master's - 25% (no Master's - 0; 14 to 16 points - 1; 17 to 18 points - 2; and 19 to 20 points - 3);	25%

A3. Scientific curriculum - 35% (rating from 1 to 3, valuing the scientific activity of the candidates, namely the involvement in research projects and the scientific production): no publications - 0; communications - 1 point; international publications as co-author - 2 points; and international publications as 1st author - 3 points.	35%
A4. Professional curriculum - 15 % (rating from 0 to 2, valuing professional experience): no experience - 0 points; little experience - 1 point; relevant experience - 2 points.	15%
B. The candidates with the highest grade in the curriculum evaluation will be invited for a face-to-face interview (50%). The number of candidates to be invited for an interview will be defined by the Scientific Committee according to the number of vacancies and candidates.	50%
C. The final seriation will be determined by the average of the curricular evaluation and the interview.
