3rd Cycle of Studies in Experimental and Clinical Pharmacology and Toxicology

A – Specific conditions for access to the cycle of studies

According to the general regulations of the 2nd and 3rd cycles of U.Porto, this information is the responsibility of the CS Scientific Committee and is subject to approval by the Director of the Faculty. Exception made to **cycles of studies together with other HEIs (Higher Education Institutions)**, to which the principles defined in the respective collaboration agreement apply, as well as in the specific regulation of the cycle of studies, formulated according to the Legal Regime of Higher Education Degrees and Diplomas (Portuguese Decree-Law nº 65/2018, of August 16).

Whenever possible, it should be mentioned the scientific areas of the qualifications required for the application.

Specific conditions for access to the cycle of studies

- 1- Undergraduates or holders of a master's degree in Medicine, and other areas related to Biological and Health Sciences, with a minimum grade of 14 values, obtained in Portuguese or foreign universities, may apply for the 3rd Cycle of Studies in Experimental and Clinical Pharmacology and Toxicology;
- 2- Undergraduates or masters from other origins may also be accepted, upon evaluation by the Scientific Committee;
- 3- After curricular assessment carried out by the Scientific Committee, undergraduates or holders of a master's degree with a final grade of the cycle of studies lower than 14 values may be admitted to enrollment in the 3rd Cycle.

B – Selection and ranking criteria and sub-criteria for applicants

Selection and grading criteria should be defined using clear, objective, easily applicable, and justified variables to safeguard the transparency and accuracy of the assessment of applications. The assessment of criteria and sub-criteria measured through a numerical scale allows a more objective assessment of the potential and academic / scientific/artistic / professional capacity of the applicants.

B – Selection and ranking criteria and sub-criteria for applicants

The ranking of applicants is done by the curriculum and the interview with the same weighting (50% each).

CURRICULUM

In the curriculum analysis, the professional and the scientific curriculum are met. The professional curriculum in the areas of Medicine, Pharmaceutical Sciences, and Biomedical Sciences is valued as follows:

Professional Curriculum



a) Professional experience in the respective area (measured in full-time equivalents): more than one year = 2 points; and up to one year = 1 point;	
b) Research grant holder: 1 point;	
c) None of the above: 0 points.	
Scientific Curriculum	
The scientific curriculum is valued as follows:	
a) For each publication in an international journal with editorial arbitration: 10 points;	
b) For each publication in a Portuguese magazine: 5 points;	
c) For each communication in international congresses: 3 points;	
d) For each communication in national congresses: 2 points;	
e) No publications: 0 points.	
INTERVIEW	50%
The interview is made to assess the availability of time, professional knowledge, ease of communication, and mastery of the English language. Each item is assessed on a scale from 0 to 3 (0 = unfavorable; 1 = favorable with reservations; 2 = favorable; 3 = very favorable) and the sum is calculated.	
Applicant's tie-breaking criteria (can be the ranking of some elements of the previous table)	
In the event of a tie, curriculum appreciation prevails.
