Students are expected to develop and deepen their knowledge of personal data protection and related good practices, by giving them the knowledge and promoting the skills to identify personal data, especially those of a sensitive nature, and to identify limitations to their processing in the health area, as well as the ability to deal with such limitations in a responsible way, in order to ensure legal compliance of the collection and processing of personal data, in light of the regulatory framework in force, taking into account the specificities of the health area, including health research, the articulation with associated ethical challenges, and the combined use of appropriate techniques, methodologies and tools to promote the protection and responsible use of data in the field of health.
